



ESSA LANDS ANOTHER MAJOR PLAYER WITH 888 SIGN-UP

Brussels, 18 January 2016: 888sport has become the latest operator to join the betting integrity body ESSA. 888sport is part of 888 Holdings PLC, incorporating a number of gambling brands and with licences in multiple jurisdictions. It has been a major sponsor of sport, including Spanish Primera Liga club Sevilla, the Grade 1 Tingle Creek Chase, Giro d'Italia and the World Grand Prix snooker tournament. Last year, 888sport announced that it would be the main shirt sponsor of English Championship football clubs Birmingham City, Brentford, Nottingham Forest and Preston North End for 2016/17 season.

Khalid Ali, Secretary General of ESSA, welcomed 888sport's decision stating: "The operator is a leading player in the industry and I am delighted that it has joined ESSA. It is the perfect start to 2017 and builds upon a very successful 2016 both in terms of membership growth and the association's ability to protect its regulated members from betting related fraud. 888sport will now add its unique customer base and betting market platforms to our global anti-fraud alert and reporting system."

Joining ESSA is a key part of that approach and to maintaining the high standards of responsible gambling that we are committed to. ESSA holds positions on match-fixing policy forums at the European Commission, Council of Europe and the IOC. It is driving a number of activities aimed at addressing match-fixing, including a player education programme with EU Athletes (see here) and an international project, entitled "Keep Crime out of Sport", led by the Council of Europe and funded by the European Commission (see here). ESSA and its members also co-fund an education programme on gambling with EU Athletes that reaches out to 15,000 athletes/players across at least ten different sports in 13 EU countries.

ESSA continues to play a key role as the regulated betting sector's representative body at national and international match-fixing policy forums and holds positions on working groups at the European Commission, Council of Europe and the International Olympic Committee (IOC). The organisation is continually reassessing and improving its alert and reporting systems and has established information sharing arrangements with a range of sports bodies and regulatory authorities.
